Appellate Authority to file the Appeal in MTNL, Mumbai

Where a consumer is not satisfied with the redressal of complaint by Complaint Centre, or his complaint remains unaddressed or no intimation of redressal of the complaint is received within period specified in Bench mark, such consumer may prefer an appeal to the Appellate Authority of concerned GM for the redressal of his complaint by post / email / in person / Fax.
